#### **BOARD MEETING LGMS 12-10-14**

12:40 pm, 8 members present, plus Isla. President Bryant Hiiter reported that we have received a letter from the school regarding an increase in our monthly rent. All present agreed that we are still pleased with our shop and agreed to the increase.

Our new computer is here and in use. Bob Krautheim, our silversmith, would like to use the old computer for club purposes. Motion to approve this was made by Ed and seconded by Bryant. All in favor.

Paul opened discussion on limiting access to our computer for club use only by officers and editors. Nothing was resolved at this time, the board will address this at a later date.

There was discussion regarding our website. The 6 months payment that was authorized is expiring. Peggy Petito made a motion to authorize another 6 month payment to our web mistress, Emily. This was seconded by a Gayland. All were in favor.

There was discussion regarding a possible charge for transactions among members (selling equipment, rocks, and finished pieces) for the club to make a profit from the sales. Informal vote: charge - 2 votes, against – 6 votes.

Discussed: what to do with old items (microwave, coffee pots, etc.) that are no longer working or in use. It was decided to speak to Maintenance.

Gayland said that several of the grinders and wheels have deteriorating metal shields that need to be replaced. Margaret stated that she will call a former employer that does sheet metal work to come out look at our machines and give us a price on repairs.

Show planning: Peggy stated that Sybil has been invaluable in buying, preparing and serving food before and during our show but she is overworked. She needs additional help to assist full time in the kitchen at our next show. We also need someone to be in charge of signs and advertising. Bryant passed around some information he had from other clubs regarding this. It was decided to ask again for volunteers to serve as show chairman, advertising czar, and prize drawing chairperson. Chuck Amberger our previous show chairman has offered to share what

it takes to be a show chairman, his lists and diagrams regarding electrical layout and floor layout.

Peggy has asked permission to destroy old receipts, checks etc She was advised to use her discretion.

Paul continued discussion on revisions to the Constitution. All club documents must be in sync with each other, some spelling must be corrected and the club address must be corrected in some places. In addition, the concept of future "life members" will be removed from the constitution. Paul has agreed to continue with the "tweaking" these items and will discuss this at future board meetings before bringing this to the general membership meeting.

#### What is Fluorite?

Fluorite is an important industrial mineral composed of calcium and fluorite (CaF<sub>2</sub>). It is used in a wade variety of chemical, metallurgical and ceramic processes. Specimens with exceptional diaphaneity and color are cut into gems or used to make ornamental objects. Fluorite is deposited in veins by hydrothermal processes. In these rocks it often occurs as a gangue mineral associated with metallic ores. Fluorite is also found in the fractures and cavities of some limestones and dolomites. It is a very common rock-forming mineral found in many parts of the world. In the mining industry fluorite is often called "fluorspar."

#### **Physical Properties of Fluorite**

Fluorite is very easy to identify if you consider cleavage, hardness and specific gravity. It is the only common mineral that has four directions of perfect cleavage, often breaking into pieces with the shape of an octahedron. It is also the mineral used for a hardness of four in the Mohs Hardness Scale. Finally, it has a specific gravity of 3.2 which is detectably higher than most other minerals. Although color is not a reliable property for mineral identification, the characteristic purple, green and yellow translucent-to-transparent appearance of fluorite is an immediate visual clue for the mineral.

#### Fluorescence

Fluorite typically glows a blue-violet color under short-wave ultraviolet and long-wave ultraviolet light. Some specimens are known to glow a cream or white color. Many specimens do not fluoresce. Fluorescence in fluorite is thought to be caFluorite Occurrence.

Most fluorite occurs as vein fillings in rocks that have been subjected to hydrothermal activity. These veins often contain metallic ores which can include sulfides of tin, silver, lead, zinc, copper and other metals. Fluorite is also found in the fractures and vugs of some limestones and dolomites. Fluorite can be massive, granular or euhedral as octahedral or cubic crystals. Fluorite is a common mineral in hydrothermal and carbonate rocks worldwide. It is used when trace amounts of yttriium, europium, samarium or other elements substitute for calcium in the fluorite mineral structure.

#### Uses of Fluorite

Fluorite has a wide variety of uses. The primary uses are in the metallurgical, ceramics and chemical industries; however, optical, lapidary and other uses are also important. Fluorspar, the name used for fluorite when it is sold as a bulk material or in processed form, is sold in three different grades (acid, ceramic and metallurgical).



Colorful pieces of fluorite can be cut into beautiful cabochons and other ornamental objects. However, because of its low hardness and perfect cleavage, it is not suitable for many purposes.
