#### Serpentine

Serpentine is named for its appearance, using the Latin word *serpentinus* which means serpent-like. Serpentine is translucent green, though it is also found in yellow, white and gray, with a mottled appearance that looks like scales and is often described as having a "greasy" or silky feel and has a hardness of 2.5-3.

**The Serpentine Group** Serpentine is the "brand name" for a group of polymorphous rocks within the serpentine group; these rocks are sometimes called Serpentinite. *Polymorphous* means that the rocks have the same chemical compound with the molecules arranged differently. So the hydrous magnesium iron phyllosilicate polymorphs of Serpentine are classified as; Antigorite, Chrysotile, and Lzardite, all chemically the same, just having the chemicals bonded in a different way. In other words; the Serpentine group consists not only of Serpentine, but of Antigorite, Lizardite, and Chrysotile: all green stones with a scaly appearance and the same basic chemical structure.

The appearance of serpentine varies depending on the structure of the bonds within the stone at the time of metamorphosis. Antigorite is named for the Antigoro Valley in Italy, where the stone is most commonly found within quarries. Antigorite is also found in Rhode Island, where it is compacted and known as bowenite, Rhode Island's state mineral; as well as found in Maryland and Pennsylvania. Antigorite forms in fine plate-like crystals bonded with mica and is used for carvings, beads, and other jewelry applications and can be used as a substitute for jade.

Lizardite, the most common type of serpentine used in home décor, is often referred to as green marble. Lizardite is a fine-grained serpentine with perfect cleavage and can be white, yellow, or green. The type we find in our home is usually a dark green with veins of calcite running through it. It also takes a high polish and is harder than marble, though it doesn't weather well when subjected to the elements.

The most common form of serpentine is called Chrysotile and forms in cylindrical crystals that double back on themselves, forming long threads of asbestos within the rock. This type of serpentine is used primarily for the asbestos fibers due to their fire resistance and flexibility. Chrysotile is mined in New York, New Jersey, and other areas along the Appalachian Mountains, California, Arizona, and Quebec near the town named Asbestos.

**Serpentine and Asbestos: You're Safe** We are all familiar with the health risks from asbestos so as a side-note here, asbestos confined within a stone is not dangerous, it becomes a health risk only when it is airborne. Asbestos workers are the most at-risk for health concerns from overexposure to asbestos and industry standards have been changed to protect them. This all sounds very scary; I mean who wants to put their health at risk over a rock?

Well, put the fear away and keep in mind that though asbestos may create health problems, it's really only been seen in people who work in industry where there is an overexposure to asbestos fibers and as long as asbestos is sealed, either within the stone or through other means, the health risk is minimal.

**Finding Serpentine: California Road Trip!** Okay, so let's go to where serpentine is plentiful, beautiful, and the official state rock; California! Since serpentine is formed from rock under high pressure and low heat, we see it a lot in the basalt along the sea floor. In California, the sea floor is being moved and subducted, so serpentine has come to the surface and is under most of the state. You can tell serpentine soil from other soil in the region. Serpentine soil is not very kind to plants and contains a lot of clay, so you can readily see the green stone with very sparse vegetation within it.

Note: This supplement is presented by David Worden, proposing changes to the by-laws to reflect the recommendations of the financial committee. **Bold type** indicates suggested changes; *Italics* indicate Dave Worden's comments.

page 2 Article VII Add sub section h. Hardship Page 3 OK through section 3.c. Pages 3 and 4

#### Section III MEMBERSHIP

revise section a) 1) to read Regular Members - Regular members will be defined as those whose dues are currently paid in full and are 21 years old or older. revise section a) 2) to read Honorary Members - see item g) below

#### Section III MEMBERSHIP

delete sections d), d)1), d)2), d)3), and replace with:

- d) Dues and fee structure is to be recommended by the Board of Directors and presented to the membership for approval. A notice of the proposed structure shall be published in the Club Bulletin prior to the Regular or Special Meeting at which the recommendation will be presented. A majority vote of those regular members present will cause the recommendation to be adopted and the new fee structure will be effective immediately or upon a date defined in the adopted recommendation.
  - 1) One half of the current dues rate will apply for current memberships initiated any time after September 1st and until December 31st.
  - 2) The current dues and fee structure will be published monthly in the Club Bulletin.
  - 3) Once approved the dues and fee structure will be effective for a minimum of 12 months from the effective date unless a new structure is approved by a minimum of 75% of the members voting on a motion to revise them.

Item 4) remains unchanged.

Old Item 5) deleted.

Old item 6) becomes item 5) without change

Old item 7) becomes item 6) with the additions in bold with each word capitalized and deletions in strike-through font

6) All guests must be accompanied by a member of the club. Guests may visit a maximum of two (2) times per calendar year and sign the waiver and pay \$1.00 per visit the current daily shop usage fee per visit. For their first visit, they must be supervised by the sponsoring member or another experienced member of the club, in the manner described in Section III e)4)

**Section III f), below**. If they desire to use the facilities more times than the two visits per year, they must apply for membership or, if in a family membership, they must pay the annual shop fee **and pay the appropriate dues and fees.** 

Old item 8) to become item 7) without change in wording.

Old item e) to remain unchanged.

Old item f) to be revised by deleting the two words in strike out font.

f) The club shall mail a statement to any delinquent member as of February 1st. Any regular member who, after having been so notified, and who has not paid his dues by March 1st shall lose the membership.

page 9 Section VII Add sub section

b) 8) Hardship. The Treasurer will also serve as the Hardship Officer and will be responsible to determine if a dues reduction is warranted for any member(s) due to financial hardship. Such reduction will be at the sole discretion of the Hardship Officer and will not be reviewed by any other Officer, Board Member, or other club member.

The changes above are all driven by the change in dues and fee structure and no other changes are required in that regard.

The comments below suggest that some further changes might be advisable.

page 5 item i)3) - Do we really expect ALL member of the BOD to sign that letter?

page 6 item d) "The President shall be an ex-officio member of all Standing Committees and shall perform each other duties as usually pertain to the office of President. He or she shall perform such duties as usually pertain to the office and as partially outlined below."

Isn't this a bit redundant?

page 8 Section VI item c)

"The Board of Directors shall direct all activities of the Society as defined in Article II as well as" act as "custodian of all physical assets of the Club." *I think we should add the words "act as".* 

#### page 8 Section VI d)

Actually, the Chairperson of the meeting (not necessarily the President) is the person who cannot vote except in case of a tie. If the President wants to make a motion, for example, he/she would step down as Chair and the VP or someone else would assume the role of Chair and the President could then make a motion AND vote. The Chair can do neither.

#### page 9 item 6)

The item requires the Shop Committee Chair to "develop an operating budget to be presented to the Board of Directors". I saw no such animal while on the committee to determine whether we needed to raise due and/or fees! It would have helped.

#### page 9 Section VIII a)

The item says that "amendments and/or revisions to the Constitution shall be presented in writing to the By-Law Committee". There is no standing committee authorized as a By-Laws Committee. To whom would one submit recommended amendments and/or revisions??

page 10 Section XIV

item a) requires that "all annual membership dues and all other money not specifically designed for a special fund" be credited to the General Fund.

item d) requires the "The Treasurer shall keep separate records for each fund."

We seem to not keep track of the shop usage fees paid for silversmithing and glass work. We saw no line items for these when working on the dues revision. I can't remember if there was a line item for the grinding shop fees.

In general, our finances are not tracked in sufficient detail. We need to acquire a book keeping program for the club that helps to properly account for our various funds yet shows ALL of our income and expenditures as part of a whole.
