LGMS General Meeting Minutes

held in Settlers Park on 7/21/2020

Includes safety rules for returning to the workshop when given approval.

A) Call to Order – 6:29 pm

- 1. In Attendance: a total of 45 members including board members.
- Motion to approve minutes with no changes by Anne Marie, 2nd by Linda with unanimous vote to approve minutes.
- B) Finances In good standing currently.
 - At the Aug. 18th general meeting there will be a vote to **increase membership dues** due to rent increase for the shop. Two options of how to raise more money to cover expenses:
 - a. Increase annual membership dues to \$60.00/year with a \$5.00 discount if paid before or on due date.
 - b. Increase daily lapidary shop fees to \$2.00.

C) SHOP OPENING 1 DAY ONLY MONDAY 8/10/2020 from 9-4 for

members to collect any of their personal items left in the shop. (Note: this date is now tentative – watch the LGMS FaceBook page for updates.) You must call Zach to schedule a time to retrieve your items. Only 1 person at a time will be allowed in the shop.

D) Once given final approval to open the shop to work, there will be limited work hours per person with an estimated two shifts available, an on-site monitor, a

temperature check taken, a questionnaire to fill out, masks must be worn, no eating, and you must sign in and out daily.

E) Masks will be available for purchase at the shop with prices \$1, \$5, or \$10.

F) The American Of Federation of Mineralogical Societies has awarded George & Anna an award. In their honor, two \$4,000 scholarships will be given to two U of M Earth Science Students. Sherlynn is working with U of M to sponsor the event.

Once we are able to return to the shop, several rules must be followed for safety. These rules follow state and local mandates and have been approved by the school and by the LGMS Board.

G) <u>New Shop Safety Rules Upon</u> <u>Return</u>

- 1) **Masks -** Must be worn over the nose and mouth at all times.
- 2) **Gloves -** Plastic surgical gloves, such as Nitrile, are optional.
- 3) Eating/Drinking No eating at any time. Do not need to shut down on Tuesdays during lunch. Minimal rehydrating/drinking is allowed.
- 4) **Sign in and out -** Anyone working in the shop must sign in the time when they arrive, and sign out the time when they leave.
- 5) **Tracing -** If someone has been in the shop and becomes ill, they must contact Zach, Cinda, or any board member so we can call other people who were in the shop on the same day, so they can quarantine.

6. **Occupancy Limit -** Limit of 8 people in the shop (including monitor) to start. Work at every other grinder, or polisher, to obtain distance.

7. Monitored Shifts

- a. Time Slot Schedule will be available once hours of operation are approved.
- b. Break work times into approximately 3 hour shifts, with a reliable club member to monitor signing-in, mask wearing, safety procedures, and sanitation.
- c. If demand is high for certain time slots a lottery can be used.
- d. Requests for monitors will be on the "Members Only" FaceBook Page soon.
 - i. Monitors that signed up at the meeting include: Sheila York, Lori Keefer, Isla Mitchell, Sherry Peterson, Jane Richard-Lerma, Marianna Ziegler, Mel Swartz, Ann Marie McFadden, Greyson Becktold, Lori Irvin.
 - ii. If you would like to be a Monitor, please contact Zach with your name, phone number, best days for you and if am or pm is better.
- 8. **Signage -** New rules will be posted at both entrances, the website, and on our Facebook pages.

9. Mask denier procedure

- a. If a person chooses to not wear a mask, they are not allowed to work in the shop on that day. Masks will be available onsite and for purchase (\$1-10).
- b. Solidarity is key. All members present must support the monitor and set a good example by wearing their mask.
- c. If there is an issue, we will utilize the school's De-escalation Policy.

10. **Fans -** With new information about the virus particles hanging in the air, it is recommended that the fans stay off, so they do not blow contaminated air around the room.

11. Sanitation/Sterilization

- a. Procedures
 - i. Closers must sanitize all handles, water valves, switches, movable lights, tables, and other high contact surfaces, with 99.5% alcohol, on cloth-like paper towels, at the end of every day.
 - ii. If alcohol is not available, hydrogen peroxide, or a bleach solution can be used instead.
 - iii. Deep cleaning, and/or steam cleaning, will be done on Fridays after closing at 2 pm.
 - iv. Daily fee, pens, pencils, and money might be contaminated. People can use their own pens if desired, and hand sanitizer will be provided next to the wallet. Hand washing is encouraged.
- b. Products to be purchased:
 - i. Bill has sent website links for rubbing alcohol, and empty bottles to buy.
 - ii. Jane Richard-Lerma has offered discounts on alcohol.
 - iii. Cinda will buy heavy duty paper towels from Rural King, based on Bill's information.
 - iv. Walmart might have hand sanitizer.
 - v. Need paper/surgical masks for sale.

12. If **future mandatory shut down** of the shop is required:

Shut-Down Shop Procedure List

1) Clear refrigerator out
2) Unplug water pump
3) Unplug coffee pot machines
4) Unplug dop pots
5) Make sure fans are OFF
6) Clear out money from the safe
7) Empty water out of trim saw
8) Check seals on all water machines
9) Turn of all polishers
10) Remove oily rags
11) Remove Ed's briefcase

H) New Business

- 1. No new members will be accepted until further notice. Motion by Sherlynn, and 2nd by Sheila. Vote taken with majority agreement (34 of 45) and passed.
- **I) Adjournment** at 7:11 pm motioned by Cinda; 2nd by Jim with unanimous vote taken to adjourn. This was followed by several members selling their rocks, slabs, cabs, masks and other items! Great to see everyone!


